Please refer to the detailed steps below for checking or obtaining a copy of the certified answer with the usage model. 1. Please download and print the notices provided at the link below on A4 paper free space (in English if the media is in English, if the media is in Hindi, if the media of the exam is Hindi). Signed scanned applications that are clearly read must be uploaded. A list of documents that will be provided with a copy of the app/certification will be taken from your selection made through the portal and not from what is written in the scanned image. In the event that the scanned image uploaded does not comply with the above parameters, the online application for verification will not be considered for any action and no refund fee for the same thing will be considered. 2. If the applicant appears for the exam in Hindi, then the necessary details on the application form must be in Hindi, and in case the applicant appears for the exam in English, then the application must be in English, your application is looking for a copy of the certified answer book, should be in your own handwriting and signed by you. In case you subscribe online, you will need to upload a scanned copy of your signed handwritten request. Students can download the application form to check the answer sheet from the following link. There are no provisions for submitting applications for a copy of the book of responses that have been assessed with a late fee. b) In case you are a general competency test (CPT) / post qualification course (PQC) check, you can submit a physical application to check/supply a copy of the certified answer book in the regular course along with draft requirements for the relevant fees. The facility to submit an online application for CPT is not yet available. Without the need to send a print job of the online application by Speed Post, you will need to upload a handwritten application signed by you by searching for a certified answer book copy for the purpose of matching your handwriting with that in the answer book. The handwritten application should be in handwriting and not capital letters. In case you are a medium-sized Hindi candidate, your handwritten application uploaded on the portal should be in Hindi. Please note that if the scanned image uploaded is not your handwritten application, but in other documents, your application will not be processed by the office. Such applications, even if they are successful transactions, are not considered valid applications and will not be processed. It can be said that wherever the question paper is in MCQ format, and the answers written by the applicant on the OMR answer sheet, only a copy of the OMR answer sheet will be received upon receipt of the application in this regard under this scheme. There is no MCQ paper book or answer key there in that section of the document.
